- **Step 1:** View the up-to-date IBM approved charity list at <a href="www.ibmretireecampaign.com">www.ibmretireecampaign.com</a>. If your charity is not listed, you may write-in an eligible not-for-profit 501(c)(3) agency's name, address, phone number and email, in the section at the end of this form. Please note, religious organizations such as churches, synagogues, etc. do not qualify unless the donation is being made to program that serves the community such as a homeless shelter, food bank, literacy program, etc.
- **Step 2:** Choose your Direct Contribution option by making an 'X' in the box that reflects your preferred method of donation.
  - A. Agency Website: You may make your donation directly through the agency's website (if available) by following the agency's website donation instructions.
  - B. Stock: The transfer of shares of stock must be made directly to the agency by the retiree (or designee).
  - C. Charitable Trust Fund: You must contact the appropriate party to execute the transfer of funds.
  - D. Personal Check: Please make personal checks payable and mail directly to the agency.
